Guidelines for Dissertation on Field work

(PGDISM)

Post Graduate Diploma in Industrial Safety Management is a one year P.G. Diploma aimed at conceptual and practical skill building of the student in the field of safety management. In the partial fulfilment of the completion of the Diploma a student must undergo at least one month practical training before the diploma is awarded. During the training, the trainee will learn some practical realities of the various aspect of safety in factories and other organisations under the guidance and supervision of experienced officers from the relevant field/faculty members.

- 1. The minimum time requirement for training period is one month.
- 2. A student may go for training in firms involved in production or institutions into the various aspects of Industrial Safety, Industrial Toxicology, Environment Pollution and Occupational Health, Industrial Hazards and Accidents, Safety Legislation and Codes etc. from relevant field.
- 3. Any experienced officer from the relevant field is required to supervise the training.
- 4. Each training report must have a certificate in original from the supervisor as per prescribed format(Annexure-II). The supervisor is expected to certify the work and conduct of the student during the training and recommend the same for evaluation for the award of Post Graduate Diploma in Industrial Safety Management.
- 5. A complete bio-data of the supervisor must be attached in the report as per the prescribed format (Annexure-III).
- 6. A written report is to be prepared by the student soon after the completion of training. The report may describe the brief outcome of the practical training completed by the students.
- 7. The contents of the report must consist of the following:
 - i) Introduction to the Topic
 - ii) Objectives of the Study
 - iii) Research Methodology
 - iv) Analysis and Interpretation of the Data
 - v) Findings and Suggestion
 - vi) Select Bibliography/References
- 8. The typed report may be about 50 to 60 pages in length and must be in hardbound form in Dark green colour.
- 9. The title page and title cover of the report must be in the prescribed format (Annexure-1). The title cover of the dissertation must be in golden letters, so that the Title of the project should be clearly visible on the cover.
- 10. The dissertation on field work must be countersigned by the Director/Principal of concerned study centre with the seal in the case of student who was enrolled through the Study Centre.
- 11. Such report will be evaluated by the examiner out of 100 marks and will be an integral part of comprehensive viva-voce examination.
- 12. The report of two or more students cannot be indentical. A declaration to this effect shall be recorded by each student as per the prescribed format (Annexure-IV).
- 13. One copy of Report along with one soft copy in the shape of CD/DVD must be sent to the Director, Distance Education GJUS&T, Hisar by 30th April every year as per schedule/rule mentioned in the prospectus. One hard bound copy of the dissertation should be retained with the candidate so that he/she could bring it at the time viva-voce examination. The

- CD/DVD must be superscribed with detail of candidates Roll no, Title and name of course with Session with permanent black Marker. The same should be pasted in plastic envelope at the inner side of the back cover of Report.
- 14. It is clarified that the date on which the aforesaid Report is submitted duly complete in all respect shall be considered the date of receipt in the Directorate and the late fee, if any due, on that date shall be charged.
